SECTION 4: First-aid measures

4.1 Description of first-aid measures

General notes

Do not leave affected person unattended. Remove victim out of the danger area. Keep affected person warm, still and covered. Take off immediately all contaminated clothing. 5.2 Special hazards arising from the substance or mixture

SECTION 7: Handling and storage

7.1 Precautions for safe handling

Recommendations

- Ventilation requirements

Keep any substance that emits harmful vapors or gases in a place that allows these to be permanently extracted. Use local and general ventilation. Ground/bond container and receiving equipment.
